Dear Friends,

The year 2024 was an exciting year at First Presbyterian Church of Ridgewood New Jersey as we lived into our calling to be a Matthew 25 congregation, with an emphasis on congregational vitality!

A clear, although somewhat wordy, description of congregational vitality, provided by the PC(USA), includes the following:

- challenging members to grow as joyful leaders and disciples,

- seeing new disciples engaged in ministry,
- seeing long standing believers develop in faith,
- sharing the gospel of Jesus Christ in word and deed.

Last year, we did all the things that make us a church. We gathered weekly for worship and fellowship; our Deacons and others provided compassionate care for our members when needed; we celebrated baptisms, received new members and held funeral or memorial services for some of our beloved family members; we taught our children in Sunday School about God's love and living the God way; and we engaged in mission with our money and our volunteers.

No look back on 2024 would be complete without acknowledging with gratitude the generous gifts from Dwight and Jo-Ann Massey and Leo and Laura Magrath which enabled the renovation of the church kitchen. Thanks also to the Paul & Alpha Jo Haffey Estate, the First Presbyterian Church Endowment Fund and Trinity Presbyterian Church whose gifts helped fund the renovation as well. Our new kitchen is up to code, looks beautiful, and will meet our needs for food and fellowship events for many years to come!

And no look back on 2024 would be complete without acknowledging that we experienced, at times, cash-flow issues and/or cash-shortage issues – which made doing the work of the church challenging. Going forward, my hope is that we can continue to raise revenue through our giving and through the contributions from community partners who use our facility, while at the same time, acting as faithful stewards of the resources at our disposal.

As we look forward to 2025, I am excited to share with you that we are planning an adult mission trip to Lewisburg, WV to volunteer with Almost Heaven Habitat for Humanity, and 12 First Pres members have committed to participating.

Furthermore, the Mission, Peace & Social Righteousness Team and the Matthew 25 Task Force are planning a number of activities designed to engage members and friends as we strive to share the love of Christ with neighbors near and far:

2024 was another wonerful and spiritually fulfilling year of making music to the glory of God at First Pres. In my 14th year as Director of Music, I continue to be grateful for the talents of our excellent soloist/section leaders Vera Coleman, Carol Schmiedecke, Joshua LeRose (formerly our 2019-2020 Choral Scholar) and Mike Schuil, as well as our wonderful organist Linda Sweetman Waters, our instrumentalists guitarist Brian Princing, cellist Emma Schmiedecke, oboist Luka Marcoux, the talented and faithful members of the Chancel Choir, as well as the Chancel Bells, Chamber Bells, and Sunday School Choir under Carol's direction. We continued our musical community outreach during 2024, again hosting the Ridgewood Singers and Orpheus Mens Chorus for their spring and holiday concerts, and the Ridgewood High School A Cappella groups in their spring concert to sanctuary-filled audiences. Our soloists/section leaders, along with singers Samantha McDevitt, Matthew Cardona, Cole Bellorgey, cellist Emma Schmiedecke and myself, continued to provide musical inspiration during the summer months.

Fall brought a return to rehearsals for the Choir and Bells, and the time passed quickly as we prepared music for Advent and our Christmas Eve service. The Sunday before Christmas Eve was dedicated to our annual Sunday School pageant, with the music for that service being provided by our youth, to the delight of the congregation. Our Sunday School Choir, directed by Carol Schmiedecke, grew from eight singers in the spring to 15 for this event! Carol also prepared vocal soloists Luke Eliya, Olivia Davis and Cole Bellorgey for their individual musical offerings, and worked each Sunday with our younger Sunday School Choir singers. The evening Christmas Eve service this year was one of the lovliest in recent memory, with the Chancel Choir, Chancel Bells, cellist Emma Schmiedecke and oboe/English hornist Luka Marcoux combining their inspiring and uplifting talents.

Once again, I would like to express my heartfelt gratitude to Pastor Bruce for his support, encouragement and inspiring leadership, to Joanne Bonwick and Diane Eliya and the Worship and Arts committee for their sustaining spirit, to MaryEllen Castaldo for her delightful camaraderie, to Dana Feeney, Tom Carozza, George Wood and our church leadership for their continued support and help with so many details. The object is to bring people together to a place where faith is encouraged in a loving and supportive environment.

The First Presbyterian Church Security Annual Report January 2025

Members: Andy Castaldi, Pastor Bruce, Tom Gibson, Jill Critchley

Background: In November 2023, we were awarded \$96K from the NJ Office Of Homeland Security and Preparedness from their NJ Non-Profit Security Grant Program. The funding is for specific site security improvements to be implemented over a 3-year period. The grant requires projects to be preapproved, managed and tracked through NJ.GOV and their Grant Tracking System, and reimbursed after completion. Projects include improved controls for how buildings are accessed and by whom, strengthening windows and doors, adding exterior and interior video monitoring for more of our buildings, and situation training. There will be announced and unannounced audits as we go through the process, and we have an assigned liaison to help up though the process.

2024 Accomplishments:

- We completed the Environmental and Historic Preservation Assessment to ensure we can conform to the historic society regulations and we are now moving forward with improving the safety of our building and occupants.
- This year security film was applied to 140 windows in the Main Office, Education Building and in the Chapel. We are obtaining bids for cameras and replacing the door entering the Education Building by the office with a more secure door. Also fire evacuation procedures have been written for the Sunday School through the Christian Ed Committee.

2025 Goals:

- Complete installation of video cameras and Security Door.
- Fire Drill practice (to be completed every year)
- Complete procedures for Sunday School through Christian Ed Committee in case of a Terrorist attack
- Develop Safety Education Programs for congregation and anyone using our facilities to prepare to respond to violent events. Please reach out if you are interested or can offer some guidance in this area.

The Property Committee oversees the Church and manse properties. We keep the buildings in good structural condition and our infrastructure in sound operating order. We also negotiate contracts to maintain the grounds and parking lots and we oversee capital improvements approved by Session.

Acknowledgements:

- This committee wants to recognize great work from Laura Magrath, Marjorie Vanacore, and Joan Davies to renovate our kitchen. We also recognize the generosity of the Massey and Magrath families, the Haffey bequest, the Endowment Fund and Trinity Church to make the project possible. The new kitchen has layout improvements, is bright, and is ready to serve our congregation.
- Recognition also goes to Joe Jackson and his basketball camp for coordinating a PSEG program to install new energy-efficient lighting in the gym AND exterior lighting around all church buildings. This work was done at no cost to us.
- Finally, Many thanks to our maintenance staff, Tom Carozza, George Wood, Michael Bertani and Jim Goudsward for your good work to keep our systems running and our buildings well-maintained.

2024 Summary:

All of our buildings are aging, as evidenced by the sanctuary approaching its 100th birthday in early 2026. Our newest buildings are 40 years old. With their age come ever-growing maintenance and repair costs. The work summarized below is the result of dedicated efforts from our committee members: Joel Torielli, Sandy Santangelo, Andy Castaldi, Richard Davies, Marjorie Vanacore, Tom Carozza, Pastor Bruce, and Tom Gibson (chair).

- Worked with families, sourced, and installed Memorial Garden bricks to remember three past members: Richard Vanacore, Lorraine Sproul, and Alan Maxfield.
- In support of the Security Team (see separate report), coordinated security film installation on education building and chapel windows to deter break-ins
- Contracted a building inspections company to evaluate the manse and church structures and identify areas that require near/medium term attention.
- Completed repairs to the manse foundation, closed and sealed a large crack in a corner of the gym, and restored brick and mortar in the cloister hallway. Moisture infiltration that caused damaged to the cloister was also addressed.
- Improved chancel illumination with additional track lighting. Thank you Jessica Strader-Paz for helping us specify and source the fixtures
- Refreshened the auditorium. Work included repairing cracked walls, reorganizing low voltage wiring for a cleaner appearance, and repainting the room. Thank you, Ivan Mashliakevych, for helping repair the walls and to Sandy (committee member) for extraordinary effort to rent and transport scaffolds, obtain all supplies, and coordinate the activities.
- Replaced the sanctuary's AC condenser fan motor that failed, forcing us to hold Sunday service in the newly refreshed, repainted auditorium.
- Re-piped the steam boilers to achieve significant reliability improvement. Many thanks to our Endowment Committee for funding this necessary project.
- Replaced a burned-out circulation pump that provided hot water heat to the chapel and library.
- Filled and repaved a sunken section of the Van Dien parking lot (across the street)
- Scraped and repainted the storage barn.
- Replaced the manse dishwasher
- With the personnel committee, updated job descriptions for the sexton and evening cleaner positions.

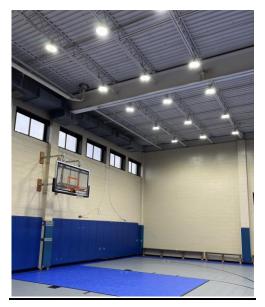

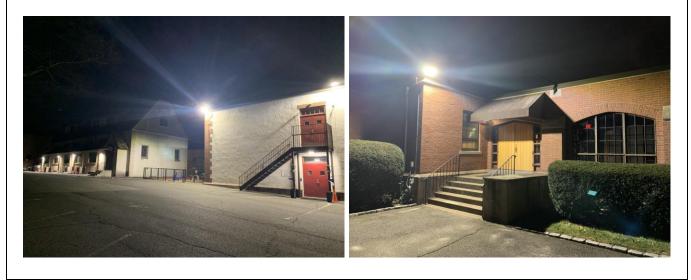

Troop 5 2024 Annual Report

We would like to thank the First Presbyterian community for their continued support and especially thank Mary Ellen Castaldo, Dana Feeney and Pastor Bruce for their guidance in 2024. We are looking forward to continuing the Scouting traditions at First Presbyterian in 2025. In 2024, Troop 5 provided Scouts with opportunities and experiences that helped them learn leadership skills, build character, and experience the importance of giving back to the community. There are currently 38 Scouts registered in the Troop, ranging in age from 11 - 17. This is a decrease of 7 Scouts from 2023.

As it has done for decades, Troop 5 focuses on boy-led planning of meetings, and instruction of younger Scouts by older Scouts in subjects such as first aid, camping, cooking and, of course, tying knots. We have continued to have scouts practice leadership and teaching skills, earn merit badges, and progress through rank advancement. Games are held at the end of some meetings, keeping things fun and engaging for the Scouts.

Troop 5 maintains one of the most ambitious schedules of all of the Scout Troops in New Jersey. In addition to weekly Monday night meetings at First Presbyterian and monthly weekend trips during the school year, over 80% of Troop 5's Scouts attended at least a week of summer camp. Eighteen Scouts, ages 11-17, attended a week of residential camp at Camp NoBeBoSco, where they learned Scout skills and earned merit badges towards rank advancement. Eight Scouts, ages 11-17, experienced a weeklong canoe trip at Floodwood Scout Reservation, where they worked together as a team to navigate treks of dozens of miles through the Adirondack State Park.

For its weekend camping trips, in addition to making traditional visits to local Scout camps and State Parks in New Jersey and New York, Troop 5 camped at Pine Hill Scout Reservation in Pine Hill, NJ. The Scouts used the camp as a base for a visit to Philadelphia and Independence National Historic Park. On these camping trips, Scouts engaged in outdoor hiking, cooking, cleaning, camp set-up, rank advancements and service projects.

Troop 5 values and instills in its Scouts a spirit of community service. Scouts learned the value of giving back to the community through donating gifts to the Valley Hospital at Christmas time, hosting the popular "tinker table" at the Ridgewood School District's Super Science Saturday, and participating in various Eagle projects. One of our Scouts is serving on the Super Science Saturday Executive Board helping plan the event for 2025. In these pursuits, the Scouts have learned the importance of being hands on, helping others, and giving with their hearts.

Eagle Scout is the highest rank in Scouting and the Eagle service project is a key part of earning the Eagle rank. In 2024, Troop 5 was honored to have four Scouts, Zachary McCotter, Isaac Lee, Jason Groehnert and Nathan Fenster, achieve the rank of Eagle. Zachary and Isaac completed their Eagle projects in 2023 but earned Eagle in 2024. Their projects were described in the 2023 annual report. Jason and Nathan's Eagle projects were painting the exterior of the Ridgewood Social Services building, and building benches and installing trail signs for the Teaneck Creek Conservatory, respectively.

On May 1st, long-time Troop 5 Assistant Scoutmaster David Bock, was awarded the prestigious Silver Beaver award at the Northern New Jersey Council annual recognition dinner for years of exceptional service to Scouting. In addition to being an active Assistant Scoutmaster, Mr Bock is the current Floodwood Mountain Scout Reservation Camp Director, a Ramapo Valley District commissioner and the Ramapo Valley District Camping Committee Chair. Troop 5 is very lucky to call Mr Bock our own.

2024 brought some continuity to the adult leadership of Troop 5. Key Three Leadership (Mrs Castaldo, Mr Moomjy and Mr Glynn) remained the same as did many of the existing Assistant Scoutmasters and Committee Members. We also had some parents of younger Scouts join the adult leadership team. Unfortunately Mr Shah stepped down as the Summer Camp Coordinator, so Mr Glynn picked up the slack while searching for a new Summer Camp Coordinator. In 2025 Mr Cheng will step down as Treasurer, so the Troop will need to fill that role as well. Troop 5 2024 adult leadership:

Hobbyists Unlimited Review 2024

As the Hobbyists fast approach its 60th year, it continues to provide both its members and the community with valuable service. 2024 in part was a year of renewal and below, we highlight some accomplishments.

Membership

After several years of decline and stagnant growth brought on by Covid, current membership stands at 419, an increase of 29 from last year. Our member profile is trending younger with the average age at 76. Our new online application process makes it easier to apply.

Social Activities

Our annual Holiday Dinner Dance at Seasons was attended by more than 160 people. This past May, our 1950s/60s theme Dinner Dance was attended by 88 people.

Each month, ROMEO (Retired Old Men Eat Out) meets at local restaurants and provides members with reasonably priced fare and opportunities to interact with colleagues. On average, about 25 Hobbyists regularly participate. Our annual picnic at Graydon Pool was attended by more than 50 people who enjoyed games, friendship and ice cream donated by Van Dyk's of Ridgewood.

The Trips & Tours group provided an interesting mix this past year. More than 50 people visited the Locust Grove Estate of Samuel Morse in Poughkeepsie, N.Y. The annual 3-day trip to Woodloch Pines (our 15th year there) was enjoyed by 65 people. The Wind Creek Casino in Bethlehem, Pa. included a stage show reprising songs by The Four Seasons and enjoyed by 26 people. Rounding out the year is a planned visit to the home and birthplace of Teddy Roosevelt, lunch at Carmine's and a trip to Grant's Tomb.

Community Outreach

Our volunteers that support Passaic County Habitat for Humanity were hard at work on new construction for eight single-family homes in Paterson.

Our Volunteer Service Club continued to provide support at Eva's Village in Paterson. The group helps set up and serve two seatings of a hot and nutritious lunch for those in need twice each month on Tuesday.

Personal Interests

In April, we reactivated the Investors Group with several well-attended Zoom presentations offered by financial experts. Our Book Club discussed works of fiction, history and even poetry with more than 20 members usually attending its monthly meetings. Movie Lovers provided interesting monthly showings at The Village Hall that are also open to the public. Our Winemakers Club, with 31 active members, had a busy year in producing classic blends of Chilean Carmenere, Cabernet Sauvignon and Merlot. They also received a prestigious award for its 2023 Opus One blend. Military History, Gourmet Cooking, Music Lovers, and World Affairs, among others, continued to provide valuable programs.

Sports and Games

Golf, our most popular activity with about 110 participants, had another busy year. In addition to their weekly outings, four tournaments and a golf trip to Atlantic City took place. Our league bowlers completed a 32-week season with 14 teams and some 60 players. Pickleball, a new offering, started in April with outdoor play and an interest in moving indoors in Winter. The Hiking group added some new members and now sponsors two hikes each week year-round. In addition, a 3-day overnight trip and an annual co-ed bar-b-que were well -received. The Walkers also added some new members and continued their weekly 4-mile jaunts starting at the Ridgewood Duck Pond. Bocce, Tennis and Fishing groups continued their popular outdoor activities. Indoors, we continued to offer Bridge, Chess, Blackjack, and Pinochle.

Last, but not least, we wish to thank Pastor Bruce, Dana, Tom and all others at the Church for their continued support of our organization. Without it, we could not exist.

First Presbyterian Nursery School

Our school has been serving the community since we opened our doors on October 7, 1968. This 2024-2025 school year marks the 56th year of First Presbyterian Church Nursery School's service in the Ridgewood Community. First Pres. Nursery School is dedicated to developing the emotional, intellectual, social, and physical growth of our students. We believe that education is a cooperative effort among students, parents, and staff, designed to stimulate the creativity and achievements of each individual child. We feel that each young person entrusted to us is important, and we consider it a privilege to be a part of each child's life! All our classes are taught by experienced, caring, and creative teachers. All teachers have a background in Early Childhood Education through college certification and/or experience and are required to attend a minimum of 12 additional hours of early childhood education training annually. All classroom teachers are CPR/First Aid certified. We are fully licensed by the state of New Jersey, with licensing renewal inspections occurring every 3 years, in addition to annual state 'mini-inspections'. At the time of this report, we have our permanent license. The next licensing audit renewal for the Nursery School will be November 2025. We are currently awaiting our annual student health record/immunization audit conducted by Valley Hospital's Community Health Dept., on behalf of the State of NJ.

In 2024, the N.S. has been actively implementing several strategies to enhance our visibility within the community. These include enhancing our marketing efforts, expanding community outreach, and introducing new programs designed to meet the evolving needs of families. Examples of these are adding testimonials to our website, launching a Facebook page, sponsoring an FPNS Ridgewood Kickball Team, being featured in the September issue of Ridgewood Living Magazine, receiving a nomination for Best Preschool in the Best of Bergen 201 Magazine, and creating school branded T-shirts to promote our identity. Our program options now include a Half Day or Full Day option for our Threes and Fours. In addition, our Twos now have the option to attend school 5 Half Days. Our Spanish, Music, and Gym curriculum continues to be very well received by our students, staff, and parents.

Registration for the 2025-2026 school year is underway. We are hosting an Open House on January 24, 2025. Interest in the Nursery School continues, and tours are being conducted for prospective families.

The success of the Nursery School is a collective effort. We appreciate our dedicated and talented staff, our supportive N.S. committee members, our N.S. Parent Committee Volunteers and all our First Pres. families.

The Nursery School, a vital part of the First Presbyterian Church revenue stream, is self-supporting with an annual budget submitted through the Finance committee and approved by Session. Fundraising efforts have raised approximately \$2,000 YTD. Proceeds from our fundraisers are funding our "in-school" field trip programs for our students as well as classroom supplies and equipment.

This has been another very successful year for the Nursery School. The children participated in the regular school curriculum as well as other enriching activities including Summer Camp, Special Person Visitation Day and In House field trips.

The Nursery School has fully transitioned to the new model of offering classes 5 days a week. This includes the options of Half Day/Full Day and includes Music, Spanish and Gym Classes. Lunch Bunch and Enrichments have been integrated into the program for Full Day students as part of the Afternoon Extended Learning focus for 3 & 4 year olds. In addition, the younger (2-1/2 year old) children will be offered 5 Half Days beginning in January, 2025.

As the NS Committee oversees the workings of the School, we are involved in working through the salary and tuition increases, making sure that our salaries are commensurate with other schools in the community and seeing that the tuition remains competitive. All of our staff except Director, Julia Bolt, are part-time.

For Teacher Appreciation Week, the Committee treated the staff to a light breakfast to honor all that they do for their students and parents. A "first" at our school was the invitation to alums to attend the end of the year program. In addition to former students, there were happily several alum parents who attended and sang the school's song with the students. See photo within NS Annual Report.

Last but certainly not least, the Committee would like to recognize the enthusiasm, dedication and creativity displayed by Julia Bolt and her staff in meeting the daily challenges of running a successful Nursery School such as ours.

Endowment Committee of First Presbyterian Church - Annual Report 2024

2024 A YEAR OF CHALLENGE

The Endowment Fundøs purpose is best defined in the following Old Testament, Genesis 45:11:

"There I will provide for you, for there are yet five years of famine to come, so that you and your household, and all that you have, do not come to poverty"

2024 began as a year of famine in our church. Endowment contributed over \$100,000 to the church. A large contribution has also been requested for 2025. While the funds have grown due to healthy investment gains, there is no guarantee that such gains will continue. Protection of principal is the cornerstone of our mission. Endowment will always be there for the church, invasion of principal will inevitably weaken the fund and ultimately result in no more Endowment monies. If in the next few years, history repeats itself we could again be faced with little or no Endowment Fund.

WHAT WE DID IN 2024~

We were blessed in 2024 with strong performance of our funds managed by Romano Brothers, a professional money manager with substantial experience working with endowment funds and non-profit organizations.

We gratefully received the following gifts in 2024:

Tree of Life \$500 (in memory of Bobbi Ballantine)

Schagen Estate \$5,000 (Al Schagen was a former member of this committee. This gift qualifies for a stone on the Tree of Life)

Memorial Gifts \$1,360 (in honor of James Davidson, Al Schagen, Fay Reid, Susi Hudson, Jim Goudsward, Karen Dexter, Mark Dance, David Johnston, Dalton Swope, and Lucy Yachechak)

Green Umbrella Note Card Program \$ 675 (includes our new Christmas Blessing cards)

We continued to help fund the Mission, Peace and Social Righteousness budget from the Haffey legacy fund in the amount of \$20,000.

We once again underwrote the Tesla media expenses in the amount of \$24,000.

We also answered a distress call from the property committee to cover the expense of \$25,000 for much needed re piping the boilers (see below pictures):

In the last quarter of the year we provided a \$30,000 loan to cover church cash flow needs. Given the challenging financial situation of the church, Endowment will forgive his loan and consider it a gift.

All of these gifts totaled over \$100,000. There can be no guarantee that this level of giving can be sustained without possible significant reductions in the available Endowment principle.

WHAT WE PLAN TO DO IN 2025~

We aim to make 2025 the year the Endowment Fund becomes widely recognized within our congregation. This is essential not only to sustain our ongoing contributions to the church but also to highlight the opportunities available for supporting the growth and long-term sustainability of our perpetual giving Endowment Fund. We encourage members and friends of the church to secure the future advancement of Godøs Kingdom by dedicating their material resources through gifts, planned giving, and bequests. The fund offers a meaningful way for members and friends to support the church through thoughtful and enduring contributions.

We will add a new row of stones to our tree of life. In addition, a new tree of life pamphlet is coming. Look for it in a pew near you!

We will continue the green umbrella \cup initiative. Cards are available in the hallway.

We will continue to help finance the Mission, Peace and Social Righteousness budget in the name of the Haffeys.

We will continue to finance ongoing property and media expenses and offer financial support to the church if we are able to do so.

I want to express my heartfelt gratitude to our dedicated, talented, and committed members. We are always eager to welcome new members to join and contribute to this ministry!

Finance & Stewardship Committee 2024 Annual Report

The Finance and Stewardship Committee reports to Session and is tasked to oversee the financial controls for the church. These functions include: managing income, expenses, bookkeeping and facilitating the annual Stewardship Campaign. The committee is also responsible for developing the proposed annual budget each year for submission to Session.

2024 was a year of mixed blessings and challenges that impacted the budget. With the assistance of bookkeeper, Lavonne McMillen, we continued to track and refine our income and expenses year over year. improved bookkeeping systems and practices. However, the church is still limited in predicting and actualizing anticipated income on which to build the budget. Unfortunately, in 2024, pledge commitments were not fully realized nor were Per Capita payments. In addition, income from the Nursery School was overestimated. And, on the financial front, we found ourselves at a crossroads particularly with cash flow.

Fortunately, the church continued to benefit from generous and gracious gifts. Non-pledge income from Offerings/Contribution came in higher than budgeted. The 2023 gift of the Massey and Magrath families for the kitchen renovation was realized in 2024 and the Haffey Fund supported capital projects including the replacement of windows, kitchen renovation as well as the annual dedication of \$20,000 for Mission. The support of the Endowment Committee and Fund also contributed to easing cash flow impacts, meeting unanticipated expenses and the pre-funding of projects identified as part of the NJ security grant.

Stewardship Campaign, Pledges

Stewardship is the faithful management of all that God gives. It is an opportunity to use God's gifts to transform us spiritually and to extend Christ's transforming love to others. Each year, our annual Fall Stewardship Campaign encourages us to review and reflect on how our giving answers Christ's call and asks us to consider what God is calling us to give for the upcoming year.

In 2024, the Stewardship Campaign was conducted during the month of October and included giving- focused Minutes for Ministry, the Officers' Dinner culminating with Consecration Sunday and the Celebration Luncheon on October 27th. This year, Steve Huston, Organizing Co-Leader and Resource Presbyter of the Presbytery of Northeast New Jersey, delivered the sermon titled "Spiritual Growth Through Giving" during worship and ninety people attended the catered Celebration Luncheon.

On Consecration Sunday, a total of 50 Estimate of Giving cards were received. And, of those, twenty-five giving units increased their pledge commitment over the previous year. The following week, an additional sixty-six cards were mailed out with return envelopes to those members who were unable to attend. In the following weeks, additional pledge cards were received. For 2025, sixty-seven giving units committed to pledging \$283,000 which is \$3,000 higher than pledge amount for 2024.

Unfortunately, during 2024 pledge revenue received fell short of the amount committed by members. Of the \$280,000 pledged, only \$264,900 in church income was actualized. This amount may be attributed to some reduced pledge income due to economic pressures, the impact of inflation, relocations and the death of members.

Some members choose not to pledge but do give on a regular basis. Those non-pledging members have continued to give generously. In 2024, \$45,447 was received as "Offerings/Contributions" along with \$5,069 in gifts from members and friends of the church as part of "Plate Contributions". While Offerings and Plate Contributions help to sustain the church, it is a challenge to adequately estimate and budget for how much revenue the church may receive in the upcoming year. This unknown directly impacts the cash flow for the ministry, mission and operations of First Pres.

Per Capita

In addition to our gifts to support the ministry and mission of First Pres, we are asked each year to meet our denominational Per Capita assessment that helps support the larger church. Members are asked to pay this annual apportionment as an action of faith, connection, commitment and recognition that we are all part of a larger Presbyterian family. For us, the Per Capita supports the work of the Presbytery of Northeast NJ, The Synod of the Northeast and the General Assembly of the PCUSA which is our national body. Each year, Per Capita envelopes are distributed to members through a mailing.

The Per Capita is based on church membership that is reported to the Presbytery as part of our annual statistical report. The total Per Capita assessment is calculated on membership numbers that are two years behind.

In 2024, the Per Capita assessment for First Pres was calculated at \$12,046 for the 317 members reported to the Presbytery for 2022. The amount designated was \$38 per member (\$2 less than 2023). Unfortunately, of that calculated amount we only received \$4,614 in apportionments from members and were not able to meet our share of the Per Capita payment to the Presbytery.

For 2025, the designated Per Capita dollar amount will remain at \$38 per member. The calculated amount of First Pres's contribution will be \$10,564 based upon 278 members reported to the Presbytery for 2023. The Finance & Stewardship Committee has proposed building this full assessment into the 2025 budget.

Property Use Fees

First Presbyterian is fortunate to support nesting congregations and community-based organizations that contribute to the overall financial needs of the church. These organizations include Trinity Presbyterian Church, Living Water Church, Hobbyists Unlimited, Connections, Summer Heat, Holmstead School as well as numerous groups who meet on a regular basis to support fellowship and community service. In 2024, we received \$142,475 in income from facility usage which represented approximately 20 percent of our budget.

The week-day First Presbyterian Nursery School housed in the education building also continues to be a tremendous asset to the church, community and the families it serves. The Nursery School develops its internal budget based on the school calendar and enrolled/registered students. In 2024, the NS contributed \$81,000 to our budget.

Endowment

The Finance & Stewardship Committee is grateful for its continued partnership and support of the Endowment Committee. For 2024, the Endowment Committee increased the "safe harbor" giving percentage from 4.5% to 5.5% annually to fund mission, underwrite live streaming, youth group and capital projects. In addition, funds were dedicated to help renovate the kitchen and pre-fund the approved projects identified as part of the NJ Non-Profit Security Grant. Endowment was also instrumental in providing funds to assist during periods of constrained cash flow.

2025 Budget

As part of the Annual Report, please find the 2025 budget approved by Session during its January 21, 2025 meeting. The goal is to present a balanced budget that takes a conservative approach to anticipated income, while realistically forecasting anticipated expenses. Unfortunately, this year, because anticipated expenses exceed anticipated income, we are presenting a deficit budget.

2025 Budget Highlights Include:

- The:budget includes a church staff salary increase of 2.5% equal to the federal COLA (Cost-of-Living Adjustment) for 2025.
- This budget includes contributions from the Endowment Fund in the amounts of \$20,000 for Mission/Benevolence and an additional \$55,000 for various other expenses.
- We have approached the various organizations which use our facility, requesting increases in facility usage contributions during 2025.
- The forecasted Nursery School contribution to the 2024 church budget was overly optimistic (it was overestimated by \$29,000). The projected Nursery School contribution to the 2025 church budget is much more realistic @ \$80,000.
- The air conditioning unit which serves the sanctuary is 30+ years old and has become increasingly expensive to maintain. Therefore, this budget includes a \$65,000 amount under Property/Special Projects to replace the AC unit.
- In addition to the \$65,000 AC expense, there is an additional \$27,154 shortfall, for a total deficit of \$92,154.

How You Can Help

Given the fact that we are facing a budget deficit in 2025, we are asking at this time that members and friends of the church prayerfully consider, as you are able: (1) increasing your 2025 pledge amount and/or (2) making a one-time additional gift to help address these two needs (\$65,000 AC replacement and the additional \$27,154 shortfall).

Anything you can do to help will be greatly appreciated!

The Finance & Stewardship Committee would like to thank Pastor Bruce Ballantine for his leadership and guidance. Thanks also goes to the Endowment Committee once again for their partnership in developing funding strategies for key projects and budgetary assistance. Much appreciation to Lavonne McMillen for her consistent attention and management of the church's financial practices/procedures and to Dana Feeney for her administrative oversight and facilitation on banking matters. Many thanks also to those members who serve as weekly counters of pledge and plate contributions. And, thank you to the Committees and their Chairs for their overseeing budgetary spending and controlling costs as needed.
